Breaking New Ground: Eisner Health & iFoster Launch Public Health AmeriCorps Program!

We are thrilled to share the exciting launch of the Public Health AmeriCorps Program by Eisner Health and iFoster. This groundbreaking initiative is not only empowering 100 emancipated foster youth from LA County by providing them with a 10-month job assignment starting in April 2024, but it also aims to establish a meaningful pathway to careers in the crucial field of public health.

We are all Friends in Texas

We are thrilled to share with you that iFoster was a key participant in the amicus brief submitted to the Third District of the Texas Court of Appeals. The brief was submitted in response to Texas' directive, instructing personnel to investigate all cases of gender-affirming care as child abuse.

We are happy to announce that the Court of Appeals has ruled favorably on its review of the temporary restraining orders granted against Texas in both the Doe and Voe/PFLAG cases. The directive has been suspended statewide pending further orders of the court. This is a significant victory for those in need of gender-affirming medical care.

Our brief argued that gender-affirming care is not child abuse, and that these invasive and threatening investigations in and of themselves did harm to the trans youth and their families. The court's decision credits the evidence presented by the appellees of harm inflicted on them by impending or actual investigations. This is a welcome vindication by the court.

Although this case will not be resolved by Texas' intervening ban on gender-affirming care, the temporary restraining orders protect families who travel out of state for this necessary care. We will keep you updated on any further developments.
